SCHOLARSHIP/ FREE SHIP POLICY

This policy outlines the guidelines and procedures for providing government and non-government scholarship benefits to students admitted through the centralized admission process and who have submitted all required documents to various government departments.

Objective:

The primary objectives of this policy are:

- To ensure that eligible students receive government scholarship and free ship benefits
 in a fair, transparent, and efficient manner, in accordance with the regulations and
 requirements set forth by relevant government agencies.
- To administered several government-sponsored scholarship and free ship schemes to support students in their pursuit of higher education.
- To assist deserving students by providing financial support, ultimately promoting equal educational opportunities and fostering academic excellence among the student community.

Applicability for Government Scholarship:

This policy applies to all students enrolled at Dnyansagar Institute of Management and Research who meet the following criteria:

- Admitted through the centralized admission process of Maharashtra Government.
- Have produced all required documents prescribed by respective departments.
- Fulfill the specific eligibility criteria as outlined by the respective scholarship programs.

Applicability for Institutional Scholarship:

- The student have taken admission in the institute and not availing any government scholarship and free ship.
- The Students who are really in need of financial support to complete the study.

Procedure for Government Scholarship:

- The scholarship section provides comprehensive information to students through notices displayed on the notice board. This includes details on eligibility criteria, required documents, and dates for online scholarship form submission.
- Students seeking government scholarship benefits submit their scholarship application form along with documents on the MAHADBT (following the guidelines provided. https://mahadbt.rnahara.gov.)

documents. The institute ensure that all information provided in the application is accurate, complete, and in compliance with the requirements of the respective government scholarship program.

- If the application and documents are found to be accurate and in compliance, the institute proceed with the next steps.
- If any discrepancies or missing information are identified, the institute communicate it to the student to rectify the issues and resubmit the corrected application.
- After successful verification, the institute submit the verified scholarship application and associated documents to the respective government scholarship department for further processing and sanction.
- The respective government department review the application and documents, and upon approval. Sanction the scholarship amount to the eligible student.
- Upon sanction, the department facilitate the disbursement of scholarship funds to the institute account /student's designated bank account in two installments.

Procedure for Institute level scholarship/Concession:

- The eligible students need to submit an application to the head of the institute for availing fees concession
- The head of the institute discuss the need for financial support with individual students and forward the application and documents to the accounts department.
- The accounts office verifies the relevant documents and student's application.
- Upon verifying the documents, the accounts department forward the same to the management for further processing.
- The students are allotted fees concession/scholarship upon receiving a positive note from the management


